Scattering of Ashes is permitted no fee will be charged on condition that permission is requested.

Hail Weston Parish Council is responsible for the management of Hail Weston Cemetery and any applications for grave spaces, burials or memorials shall be determined by the Parish Council. Residents only, may reserve a space in advance under the Exclusive Right of Burial scheme.

Where the deceased was resident in the Parish at the time of their death or at any time during the three years preceding their death, resident rates apply; those not resident in the Parish for more than three years prior to their death will be classed as non-resident. Individual requests relating to non-residents to qualify for resident rates will, however, be considered by the Parish Council where the deceased had substantial ties to the Parish.

This option to create exceptions is intended to prevent exclusion on financial grounds in cases such as when long-standing residents have moved out of the Parish more than three years prior to their death due to age or ill-health.

Money from fees is used for the maintenance of the cemetery.

The Parish Council may sell the Exclusive Right of Burial in a burial or ashes grave space to a Resident for an initial period of 75 years. A deed will be issued to the purchaser(s) who will become the registered Grave Owner. At the expiry of the 75 year period, subject to the Parish Council's permission, the rights to the grave space may be renewed by the Grave Owner or their heir for a period set by the Parish Council at that time.

At time of burial the interment fees and grave digging fees become due. Even though Exclusive Right of Burial may have been previously purchased the interment fee and grave digging fees are also due at the time of burial.

The Council reserves the right to make alterations to these charges at any time, consistent with the Local Government Act 1972 and the Local Authorities Cemeteries Order 1977. All Cemetery fees will be subject to these charges and any terms and conditions that may be in force at the time.

VAT is not charged on Cemetery fees. Cheques should be made payable to Hail Weston Parish Council.
